### 1 Overview

#### A Background

The FSA Apply Now Packets have been created by FSA Outreach in partnership with the FPAC External Affairs Division to consolidate eligibility forms and streamline the application process for new and prospective customers and agricultural partners.

### B Printing Services Request

To request printing services:

- download and complete the [FPAC Work Order Request Printing and Duplication Services](#) form
- submit the project file (PDF is preferred) with the work order form to [commsptctr@usda.gov](mailto:commsptctr@usda.gov).

USDA e-authorization is required to access the work order form. Only 1 print job is allowed per request, and standard job completion is 15 business days. The requesting office is responsible for costs. Submit questions to [commsptctr@usda.gov](mailto:commsptctr@usda.gov).

### C Customer Support

The FSA Apply Now Packets are intended to streamline the application process for new customers but should not replace the customer service and support from interactions between field staff and new customers. New customers are directed to schedule a 1-on-1 appointment at their local USDA Service Center for assistance with getting started.
